4. That the proposal is strictly devised and designed as per the latest relevant I.S.Code and specification of PWD/CPWD & Other relevant rules, procedure and guidelines are strictly followed during execution of works.
5. That the building Plan & other relevant documents of the Projects shall be authenticated by the Competent Authority before commencement of work.
6. That the e-tendering mode is followed for fixation of award of contract for execution of the Works/Projects. The DPR is followed in the formation of BOQ for e-tendering purpose of the Project. Fragmentation of the Work / Project while tendering is not allowed.
7. That there is no time or cost overrun involved in the project and the set timeline is strictly adhered to. No escalation shall be admissible under any circumstances.


