1. That the expenditure incurred for the execution of above work shall be debited to NABARD to the extent of A.A. Cost during the period of Project.
2. **That the allotment and execution of the work shall be taken up only after the sanction of the Project by NABARD and subsequent release of funds by Finance Department, JK UT on BEAMS Portal in favour of the university.**
3. That the above work shall be taken up after the fulfillment of all codal formalities laid down by the university in this behalf / the Proper codal procedure mandatory as per Standing State Government Rules / Regulations shall be adhered to for entire transparency & economy.
4. That the expenditure shall be booked for only those items/activities which are covered in approved DPR of said work which are Technical Vetted by Estates Officer, SKUAST-Jammu.
5. That the proposal is strictly devised and designed as per the latest relevant I.S.Code and specification of PWD/CPWD & Other relevant rules, procedure and guidelines are strictly followed during execution of works.
6. That the building Plan & other relevant documents of the Work shall be authenticated by the Competent Authority before the commencement of work.
7. That the e-tendering mode is followed for fixation of award of contract for execution of the Work. The DPR is followed in the formation of BOQ for e-tendering purpose of the Work. Fragmentation of the Work while tendering is not allowed.
8. That there is no time or cost overrun involved in the work and the set timeline is strictly adhered to. No escalation shall be admissible under any circumstances.
