All the desirous candidates seeking admission to M.V.Sc. programme, who appeared in the SKUAST-CET-2024 (PG), and the result of SKUAST-J CET-2024 (PG) for admission to M.V.Sc. programmes has been notified vide notification no.16 (Acad.) of 2025 dated 20/02/2025 and is available on the University website <u>www.skuast.org</u> are hereby informed that the Mop-up round of counselling to PG Programme is scheduled to be held as under:

The candidates, before attending the mop-up round of counselling must ensure that the following conditions are strictly adhered to, failing which the admission cum counselling committee shall be within its rights not to consider any request, in case of deviation of these conditions

- 1. The candidates attending counselling shall have to produce the original documents viz. Matric (D.O.B), Marks card of 10+2, Graduation Marks card/ Transcript/Provisional Degree Certificate, Domicile Certificate, Migration Certificate, Category Certificate, (if belonging to any reserved category), along with self attested photo copies of all the above documents, admit card of SKUAST-J CET-2024 and 06 Nos. of recent passport size coloured photographs.
- 2. The candidates before attending the counselling on the aforesaid date shall have to deposit counselling fee Rs. 1000/-(Non-refundable) through online mode preferably one day before or on counselling date up to 11:00 A.M positively. For details in this regard log on www.skuast.org.
- 3. If a candidate or his/her representative fails to appear for previous counsellings on the specified date but intends to appear on Mop-up round of counselling i.e. on 16/04/2025 he/she will be allowed only after depositing Rs. 1500/-(non refundable) as counselling fee. Further, the candidate shall be considered for seat in a course available at that point of time. Such candidates cannot stake any claim whatsoever on any other seat already allotted despite their merit.
- 4. The provisionally selected candidates shall have to deposit requisite fee in full on the day of counselling. Accordingly, the candidates are advised to come prepared for

- 5. The candidates provisionally selected/admitted under self-financing category shall have to make an undertaking to the extent that he/she is in a position to pay the self-finance category fee for the whole duration of the degree programme and shall not request for any concession/exemption of fee at any point during the course of degree programme.
- 6. No Up-gradation shall be permitted in the mop-up round.
- 7. The candidates are required to attend the counselling on stipulated date/time, venue and present him / herself before the counselling committee when his/her name is announced, failing which the claim of admission on seats available at that point of time when he/she was called shall not be entertained in spite of superior merit. The allotment of seats for candidates who present themselves before counselling committee afterwards shall depend upon availability of seat(s) at the point of time, when he/she presents him/herself before the Counselling Committee of SKUAST-Jammu in the Counselling Hall on stipulated dates of counselling only.
- 8. For Self-Finance Category, in each degree programme, the selection of desirous candidates shall also be strictly based on merit obtained in the SKUAST-J, CET-2024.
- 9. The candidates are advised to visit University website <u>www.skuast.org</u> for other details and updated information.
- 10. All other terms and conditions as mentioned in brochure shall remain as such.
